CS/CS/SB 994 (3R) by the Appropriations Committee on Transportation, Tourism, and Economic Development, the Committee on Transportation and Senator Burgess—

Student Transportation Safety; Revising requirements for signage posted on the rear of a school bus indicating the use of a school bus infraction detection system; requiring a law enforcement agency to send a notice of violation to the registered owner involved in a violation within a specified timeframe after receiving certain information; prohibiting the use of school bus infraction detection systems for remote surveillance; requiring that certain civil penalties be remitted to a participating school district operating a school bus with a school bus infraction detection system to be used for certain purposes, etc. Effective Date: Upon becoming a law

CS/SB 720, 1st Eng. (3R) by the Committee on Judiciary and Senator Hutson—

Asbestos and Silica Claims; Revising the information required to be included in a sworn information form for asbestos or silica claims filed after a specified date; specifying that such a form is inadmissible in evidence, and may not be relied upon by a witness, at trial; requiring courts to dismiss certain claims upon a motion by a defendant, etc. Effective Date: 07/01/2024

Online Access to Materials Harmful to Minors; Requires commercial entity that publishes or distributes material harmful to minors on websites & applications to perform reasonable age verification, prevent certain access, & provide for reporting unauthorized or unlawful access; prohibits retention of personal identifying information; authorizes DLA to bring action under Florida Deceptive & Unfair Trade Practices Act for violations; provides civil penalties; provides for private causes of action; provides certain commercial entities are subject to jurisdiction of state courts. Effective Date: 07/01/2024

CS/CS/HB 1491 (SO) by the Committees on State Affairs Committee, Regulatory Reform & Economic Development Subcommittee, Representatives Tramont and Overdorf—

Pub. Rec./Investigations by the Department of Legal Affairs; Provides exemption from public records requirements for information relating to investigations by DLA of certain age verification violations; authorizes DLA to disclose such information for specified purposes; provides for future legislative review & repeal of exemption; provides statement of public necessity. Effective Date: On the same date that HB 3 or similar legislation takes effect

Withdrawn from the Committee on Fiscal Policy

CS/CS/SB 1380 (SO) by the Appropriations Committee on Health and Human Services, the Committee on Transportation and Senator Hutson—

Transportation Services for Persons with Disabilities and the Transportation Disadvantaged; Revising membership of the Commission for the Transportation Disadvantaged and qualifications therefor; revising the duties of the commission; providing responsibilities of a transportation service provider with respect to training of certain drivers, application-based and smartphone-based ride booking and vehicle tracking services, maintenance and upgrading of all technology-based services, and the provision of pre-booking and on-demand services for paratransit service users; requiring that reports of adverse incidents be submitted to the Agency for Persons with Disabilities and the Department of Transportation, etc. Effective Date: 07/01/2024

Reported favorably as a committee substitute by the Committee on Transportation; reported favorably as a committee substitute by the Appropriations Committee on Health and Human Services; and the Committee on Fiscal Policy reports the committee substitute favorably

CS/CS/SB 1364 (SO) by the Committees on Rules, Agriculture and Senator Calatayud—

Everglades Protection Area; Requiring that proposed plans and plan amendments that apply to certain lands within or near the Everglades Protection Area follow the state coordinated review process; providing duties of the Department of Environmental Protection relating to such plans and plan amendments; authorizing site-specific text changes for small-scale future land use map amendments; prohibiting the adoption of small-scale development amendments for properties located within or near the Everglades Protection Area, etc. Effective Date: 07/01/2024

Reported favorably by the Committee on Community Affairs; reported favorably as a committee substitute by the Committee on Agriculture; and reported favorably as a committee substitute by the Committee on Rules

SB 1568 (SO) by Senator Hutson—

Fantasy Sports Contest Amusement Act; Designating the "Fantasy Sports Contest Amusement Act"; requiring the Florida Gaming Control Commission to enforce and administer the act; providing application requirements for fantasy sports contest operator licenses; requiring a contest operator to implement specified consumer protection procedures; requiring contest operators to keep and maintain certain records for a specified period, etc. Effective Date: 07/01/2024

Reported favorably by the Committee on Regulated Industries; and reported favorably by the Committee on Fiscal Policy

CS/CS/SB 1566 (SO) by the Committees on Fiscal Policy, Regulated Industries and Senator Hutson—

Fees/Fantasy Sports Contest Operator; Requiring applicants for a fantasy sports contest operator license to pay a specified application fee; requiring contest operators to pay a specified annual license renewal fee; prohibiting such fees from exceeding a specified amount; requiring applicants and contest operators to provide certain written evidence; requiring contest operators to remit certain fees, etc. Effective Date: On the same date that SB 1568 or similar legislation takes effect, if such legislation is adopted in the same legislative session or an extension thereof and becomes a law

Reported favorably as a committee substitute by the Committee on Regulated Industries; and reported favorably as a committee substitute by the Committee on Fiscal Policy

CS/CS/SB 24 (SO) by the Committees on Fiscal Policy, Governmental Oversight and Accountability, Senator Rouson and others—

Dozier School for Boys and Okeechobee School Victim Compensation Program; Establishing the Dozier School for Boys and Okeechobee School Victim Compensation Program within the Department of Legal Affairs; requiring the department to accept and process applications for the payment of compensation claims under the program; requiring the department to provide specified notice of the program; requiring the department, subject to the appropriation of funds for that purpose, to pay a specified compensation amount to approved applicants, etc. Effective Date: 07/01/2024

CS/CS/SB 26 (SO) by the Appropriations Committee on Criminal and Civil Justice, the Committee on Governmental Oversight and Accountability, Senator Rouson and others—

Public Records/Dozier School for Boys and Okeechobee School Victim Compensation Program; Providing an exemption from public records requirements for the personal identifying information in an application submitted to the Department of Legal Affairs by, or on behalf of, a person seeking compensation through the Dozier School for Boys and Okeechobee School Victim Compensation Program; providing exceptions; providing for future legislative review and repeal of the exemption; providing a statement of public necessity, etc. Effective Date: On the same date that SB 24 or similar legislation takes effect, if such legislation is adopted in the same legislative session or an extension thereof and becomes a law

Economic Development; Deleting the requirement that certain grants received by a regional economic development organization must be matched in a certain manner; removing a provision requiring a certain consideration; removing certain demonstration requirements of program applicants, etc. Effective Date: 07/01/2024

Reported favorably by the Committee on Commerce and Tourism; reported favorably as a committee substitute by the Appropriations Committee on Transportation, Tourism, and Economic Development; and the Committee on Fiscal Policy reports the committee substitute favorably

Similar to CS/HB 141(HC) in the Committee on Fiscal Policy

CS/CS/SB 208 (SO) by the Committees on Fiscal Policy, Criminal Justice, Senator Burgess and others—

Alzheimer's Disease and Related Dementia Training for Law Enforcement and Correctional Officers; Requiring the Department of Law Enforcement to establish an online, continued employment training component relating to Alzheimer's disease and related forms of dementia; requiring that the training component be developed with the Department of Elder Affairs; authorizing the completion of such training to count toward a certain requirement, etc. Effective Date: 10/01/2024

Reported favorably as a committee substitute by the Committee on Criminal Justice; the Appropriations Committee on Criminal and Civil Justice reports the committee substitute favorably; and reported favorably as a committee substitute by the Committee on Fiscal Policy

Identical to CS/HB 801, 1st Eng.(HC) in the Committee on Fiscal Policy

SB 302 (SO) by Senator Boyd—

Dental Services; Requiring every dentist and certain individuals, partnerships, corporations, and other entities to provide specified information to certain patients; requiring a dentist of record to remain primarily responsible for all dental treatments for a patient treated through telehealth; requiring advertisements of dental services provided through telehealth to include a specified disclaimer for certain dental services, etc. Effective Date: 07/01/2024

Reported favorably by the Committee on Health Policy; reported favorably by the Appropriations Committee on Health and Human Services; and reported favorably by the Committee on Fiscal Policy

Similar to CS/HB 855(HC) in the Committee on Fiscal Policy

CS/SB 320 (SO) by the Committee on Transportation and Senator Wright—

Public Records/Prospective Bidders/Department of Transportation; Providing an exemption from public records requirements for certain financial information provided by a prospective bidder to the Department of Transportation for prequalification purposes; providing for future legislative review and repeal of the exemption; providing a statement of public necessity, etc. Effective Date: 07/01/2024

Reported favorably as a committee substitute by the Committee on Transportation; the Committee on Governmental Oversight and Accountability reports the committee substitute favorably; and the Committee on Rules reports the committee substitute favorably

CS/CS/SB 388 (SO) by the Committees on Rules, Judiciary and Senator Garcia—

Motor Vehicle Parking on Private Property; Providing requirements for signage for certain parking facilities; authorizing certain entities to regulate such signage; providing requirements for invoices for certain parking charges; prohibiting the assessment of a late fee before a certain period; prohibiting personal information from being sold, offered for sale, or transferred for sale by such owners or operators, etc. Effective Date: 07/01/2024

Reported favorably as a committee substitute by the Committee on Judiciary; and reported favorably as a committee substitute by the Committee on Rules

Similar to CS/CS/HB 271(HC) in the Committee on Rules

CS/CS/SB 434 (SO) by the Committees on Fiscal Policy, Transportation and Senator Harrell—

Specialty License Plates; Providing that a certain discontinuation requirement for specialty license plates does not apply to collegiate license plates; providing that collegiate license plates are not subject to specified presale requirements for specialty license plates; authorizing certain entities to resubmit discontinued collegiate license plates for reauthorization by the Department of Highway Safety and Motor Vehicles; revising the distribution of proceeds for the Live The Dream license plate; directing the department to develop certain specialty license plates, etc. Effective Date: 10/01/2024

Reported favorably as a committee substitute by the Committee on Transportation; the Appropriations Committee on Transportation, Tourism, and Economic Development reports the committee substitute favorably; and reported favorably as a committee substitute by the Committee on Fiscal Policy

Similar to CS/CS/HB 403, 1st Eng.(HC) in the Committee on Fiscal Policy

CS/SB 1356 (SO) by the Committee on Criminal Justice and Senator Calatayud—

School Safety; Providing that sheriffs are responsible for screening-related costs for school guardian programs; authorizing sheriffs to waive training and screening-related costs for a private school for a school guardian program; requiring the Department of Law Enforcement to maintain a list of school guardians and provide the list to any School Safety Specialist upon request; providing requirements for the list; requiring each sheriff to report on a quarterly basis to the Department of Law Enforcement the schedule for school guardian trainings, etc. Effective Date: 07/01/2024

Reported favorably by the Committee on Education Pre-K -12; reported favorably as a committee substitute by the Committee on Criminal Justice; and the Committee on Fiscal Policy reports the committee substitute favorably

Similar to CS/CS/HB 1473(HC) in the Committee on Fiscal Policy

CS/SB 7056 (SO) by the Committees on Rules, and Education Pre-K -12 (Simon)—

Public Records/School Guardians; Providing that certain information relating to school guardians held by the Department of Law Enforcement, a law enforcement agency, a school district, or a charter school is exempt from public records requirements; providing for future legislative review and repeal of the exemption; providing a statement of public necessity, etc. Effective Date: On the same date that SB 1356 or similar legislation takes effect, if such legislation is adopted in the same legislative session or an extension thereof and becomes a law

Reported favorably as a committee substitute by the Committee on Rules

Identical to CS/CS/HB 1509(HC) in the Committee on Rules

SB 446 (SO) by Senator Simon and others—

Supported Decisionmaking Authority; Requiring a circuit court to consider certain needs and abilities of a person with a developmental disability when determining whether to appoint a guardian advocate; defining the term “supported decisionmaking agreement”; prohibiting such agreement from acting as a durable power of attorney; requiring a petition to determine incapacity of a person to include specified information relating to the alleged incapacitated person’s use of assistance, etc. Effective Date: 07/01/2024

Reported favorably by the Committee on Judiciary; reported favorably by the Committee on Children, Families, and Elder Affairs; and reported favorably by the Committee on Rules

Identical to HB 73(HC) in the Committee on Rules

CS/SB 496 (SO) by the Committee on Community Affairs and Senator Perry—

Low-voltage Alarm System Projects; Specifying that a nonelectric fence or wall must enclose the outside perimeter of a low-voltage electric fence; permitting low-voltage electric fences to be installed in areas within more than one zoning category; prohibiting a municipality, county, district, or other entity of local government from adopting or maintaining certain ordinances or rules that provide additional requirements for low-voltage alarm system projects, etc. Effective Date: 07/01/2024

Reported favorably by the Committee on Regulated Industries; reported favorably as a committee substitute by the Committee on Community Affairs; and the Committee on Rules reports the committee substitute favorably

Identical to CS/HB 535(HC) in the Committee on Rules

CS/SB 514 (SO) by the Committee on Banking and Insurance, Senator Boyd and others—

Mortgage Brokering; Authorizing the Financial Services Commission to adopt rules prescribing criteria and processes for determining whether an organization is a bona fide nonprofit organization for a specified purpose; providing exemptions from regulation under ch. 494, F.S., for bona fide nonprofit organizations and certain employees of a bona fide nonprofit organization that meet specified criteria; requiring the Office of Financial Regulation to make a specified determination, etc. Effective Date: 07/01/2024

Reported favorably as a committee substitute by the Committee on Banking and Insurance; the Committee on Fiscal Policy reports the committee substitute favorably; and the Committee on Rules reports the committee substitute favorably

Similar to CS/HB 1569(HC) in the Committee on Rules

CS/SB 1052 (SO) by the Committee on Community Affairs and Senator Hutson—

Inactive Special Districts; Dissolving special districts that have been declared inactive and repealing their enabling laws; dissolving the Sunny Isles Reclamation and Water Control Board and repealing the judicial order establishing the district, etc. Effective Date: 07/01/2024

Reported favorably as a committee substitute by the Committee on Community Affairs; and the Committee on Rules reports the committee substitute favorably

Identical to CS/HB 7011(HC) in the Committee on Rules

CS/SB 1058 (SO) by the Committee on Community Affairs and Senator Hutson—

Special Districts; Prohibiting the creation of new safe neighborhood improvement districts after a date certain; providing term limits for elected members of governing bodies of independent special districts; providing the method for changing boundaries of an independent special district; providing additional criteria for declaring a special district inactive, etc. Effective Date: 07/01/2024

Reported favorably as a committee substitute by the Committee on Community Affairs; and the Committee on Rules reports the committee substitute favorably

Similar to CS/CS/HB 7013(HC) in the Committee on Rules

SB 570 (SO) by Senator Burgess and others—

Alternative Headquarters for District Court of Appeal Judges; Authorizing a district court of appeal judge to have an appropriate facility in a county adjacent to his or her county of residence as the judge's official headquarters; authorizing subsistence and travel reimbursement to such judges, etc. Effective Date: 07/01/2024

Reported favorably by the Committee on Judiciary; reported favorably by the Appropriations Committee on Criminal and Civil Justice; and reported favorably by the Committee on Fiscal Policy

CS/CS/SB 602 (SO) by the Committees on Fiscal Policy, Environment and Natural Resources and Senator DiCeglie—

Release of Balloons; Revising a prohibition on the release of certain balloons to delete a specified timeframe and number of balloons; deleting an exemption from such prohibition for certain biodegradable or photodegradable balloons; providing that a person who violates the prohibition commits the noncriminal infraction of littering, etc. Effective Date: 07/01/2024

Reported favorably as a committee substitute by the Committee on Environment and Natural Resources; the Committee on Community Affairs reports the committee substitute favorably; and reported favorably as a committee substitute by the Committee on Fiscal Policy

*Similar to **CS/HB 321(HC)** in the Committee on Fiscal Policy*

CS/SB 612 (SO) by the Committee on Commerce and Tourism and Senator Hooper—

Building Construction Regulations and System Warranties; Providing that certain provisions governing the transfer of heating, ventilation, and air-conditioning (HVAC) system manufacturers' warranties apply to transfers made on or after a specified date; prohibiting HVAC system manufacturers' warranties from being conditioned upon the product registration; providing the effective date for certain HVAC system and component warranties under a specified circumstance, etc. Effective Date: 07/01/2024

Reported favorably as a committee substitute by the Committee on Commerce and Tourism; the Committee on Community Affairs reports the committee substitute favorably; and the Committee on Rules reports the committee substitute favorably

*Similar to **CS/HB 481(HC)** in the Committee on Rules*

CS/SB 688 (SO) by the Committee on Rules and Senator Martin—

Alternative Mobility Funding Systems and Impact Fees; Requiring a local government to allow an applicant for a certain development permit to satisfy transportation concurrency requirements if the applicant offers to enter into a good faith binding agreement that the project is considered to have mitigated its transportation impacts if the applicant meets certain conditions and requirements; prohibiting a local government from preventing an applicant from proceeding if the applicant has satisfied specified requirements; authorizing certain local governments to adopt an alternative transportation system meeting specified requirements under certain circumstances, etc. Effective Date: 10/01/2024

Reported favorably by the Committee on Community Affairs; reported favorably by the Committee on Transportation; and reported favorably as a committee substitute by the Committee on Rules

CS/SB 712 (SO) by the Committee on Rules and Senator Powell—

Public Records/County Attorneys and City Attorneys; Providing an exemption from public records requirements for the personal identifying and location information of current county attorneys, assistant county attorneys, deputy county attorneys, city attorneys, assistant city attorneys, and deputy city attorneys and the names and personal identifying and location information of the spouses and children of such attorneys; providing for future legislative review and repeal of the exemption; providing a statement of public necessity, etc. Effective Date: 07/01/2024

Reported favorably by the Committee on Community Affairs; and reported favorably as a committee substitute by the Committee on Rules

CS/SB 768 (SO) by the Committee on Health Policy and Senator Stewart—

Duties and Prohibited Acts Associated with Death; Authorizing that a report regarding specified deaths and circumstances be made to a certain law enforcement agency in addition to the district medical examiner; increasing the criminal penalty for persons who fail or refuse to report a death or who refuse to make available certain information with the intent to conceal the death or alter the evidence and circumstances surrounding the death, etc. Effective Date: 07/01/2024

Reported favorably by the Committee on Criminal Justice; reported favorably as a committee substitute by the Committee on Health Policy; and the Committee on Fiscal Policy reports the committee substitute favorably

*Identical to **CS/HB 1653(HC)** in the Committee on Fiscal Policy*

CS/SB 852 (SO) by the Committee on Criminal Justice, Senator Calatayud and others—

Interpersonal Violence Injunction Petitions; Revising a requirement that petitions for injunction for protection against domestic violence, repeat violence, sexual violence, or dating violence, and stalking, respectively, be verified, rather than sworn to; revising the form for such petitions for injunction to require a person to verify, rather than swear to, certain statements; requiring the clerk of the court to include an injunction in the Driver and Vehicle Information Database, etc. Effective Date: 07/01/2024

Reported favorably by the Committee on Judiciary; reported favorably as a committee substitute by the Committee on Criminal Justice; and the Committee on Rules reports the committee substitute favorably
