The specific purpose that will be achieved by the requested funds is the construction of a regional drinking water transmission pipeline with pumping and storage facilities. The Phase 3C Regional Water Transmission Pipeline is an extension of the regional drinking water transmission system that conveys drinking water from an Alternative Water Supply to Charlotte, DeSoto and Sarasota Counties. The Phase 3C Project will improve regional drinking water system reliability and meet growing water needs in Sarasota County and provide a future connection to Manatee County's water system.

b. What activities and services will be provided to meet the intended purpose of these funds?

Construction of approximately 10 miles of 42" diameter potable water transmission pipeline and pumping and storage facilities to improve water system reliability and support growing water demands in Sarasota County.

c. What direct services will be provided to citizens by the appropriation project?

This project provides a reliable and safe drinking water supply for public health, safety and welfare of the residents and economic growth of the region consisting of Charlotte, DeSoto, Manatee and Sarasota Counties.

d. Who is the target population served by this project? How many individuals are expected to be served?

The four-county region comprising the Authority's service area has a population of approximately 1,100,000 residents. The Authority's regional water supply system connects to utilities serving more than half of that population and in 2022 approximately 30 million gallons per day of drinking water was supplied to the region to support public health and economic growth.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

This project provides reliable water supply infrastructure to the region for economic development and public health and safety. The project enhances regional water supply resiliency to disasters such as drought, floods, hurricanes, and climate change. The outcome will be measured through improving water supply availability and maintaining the current high standards for drinking water quality under all foreseeable conditions.
