4. Project/Program Description

Construction of a 7,500 sq ft women's health center. PanCare currently owns the land. Cervical and breast cancer screening rates are low in the uninsured and under-insured population. Cash pay rates are burdensome, which results in women going without their annual screenings. This clinic will increase access to gynecological and breast health services in the target population. The clinic will house a mammography suite as well as multiple women's health exam rooms. We anticipate providing mammograms and gynecological services to 1,500 women annually.

14. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?

Increased diagnostic and early screening will reduce the severity of cervical and breast cancer cases in women across the service area.

b. What activities and services will be provided to meet the intended purpose of these funds?



Increase cervical cancer screening rates across the service area. In 2020, PanCare treated over 5,000 women who did not receive a cervical cancer screening. That number will be reduced by 50%. Increase breast cancer screening rates across the service area. In 2020, PanCare treated over 3,800 women who did not receive a mammogram. That number will be reduced by 50%.

c. What direct services will be provided to citizens by the appropriation project?

Gynecological services to 1,500 women annually. Cervical and breast cancer screenings and diagnostics.

d. Who is the target population served by this project? How many individuals are expected to be served?

At least 2,500 more women will receive cervical cancer screenings each year. At least 1,900 more women will receive breast cancer screenings each year.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

Early detection will result in a reduction in the severity of cervical and breast cancer cases in women, which will produce a healthier population and workforce as well as lowering the expense of long-term treatment. We will be measured by reductions in the rate of women treated by Pancare who have not received cervical or breast cancer screenings.

f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for the contract?

Repayment of funds to the state.
