Working in the schools and BGCMC Clubs, they will serve the elementary school youth to improve English Language Arts (ELA) skills among the K-3rd graders and with school guidance staff to serve the middle school students to improve academic engagement and/or social-emotional skills.

Boys and Girls Club of Martin County will have 46 AmeriCorps members who will work with certified teachers to improve educational outcomes for 1275 youth in grades K-8 in Martin County in 5 middle schools and 4 elementary schools. Working in the schools and BGCMC Clubs, they will serve the elementary school youth to improve English Language Arts (ELA) skills among the K-3rd graders and with school guidance staff to serve the middle school students to improve academic engagement and/or social-emotional skills.

b. What activities and services will be provided to meet the intended purpose of these funds?

AmeriCorps Members will implement evidence-based interventions to support the Literacy Program in the District's lowest performing elementary schools and will provide mentoring to students identified as at risk for dropping out in the District's 5 middle schools. The work will continue during after school, holidays, and summer in the organization's 4 free-standing Clubs.

c. What direct services will be provided to citizens by the appropriation project?

Members will implement evidence-based interventions in the 5 middle schools by serving as mentors to 750 students. In the elementary schools, members will implement two evidence-based interventions to 525 selected students in grades K-3. All students will be provided free enrollment in their choice of the Club's programs, where they will work with Club enrichment staff and certified teachers.

d. Who is the target population served by this project? How many individuals are expected to be served?

The target population is elementary and middle school students in Martin County. More than 800 individuals are expected to be served.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

be measured?

Middle School: 65% of the students served in a minimum of 34 sessions will improve academic engagement and/or social-emotional skills.

Elementary School: 65% of the students completing a minimum of 20 weeks of literacy intervention will improve ELA scores in 1 or more ELA domains as measured by the Benchmark Assessment (pre and post test). Middle School: Participants will be tracked using the Check & Connect system, a comprehensive, web-based case

management system designed to document, track, and report data. All students will complete an entry and exit survey. Elementary School: The Benchmark Advance Curriculum is grounded in the science of reading. Students will be assessed in the beginning of the year and at the end of the year.

f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for the contract?

Failure to meet deliverables would result in financial consequences including withholding of funding or reduction in specified payments.
