The specific goal of the site work is to enable the school to build a gym and upper school building that will provide educational and athletic needs for students, community events, and a possible storm shelter.

Site work will enable the school to build a gym which will house physical fitness classes, athletic team practices, games, tournaments, community events, and a safe space for a storm shelter. Additionally, the site work will allow the school to build an upper school building which will provide space for additional grades being added to the school (9th grade in 2023-24, 10th grade in 2024-25, etc.).

c. What direct services will be provided to citizens by the appropriation project?

Direct services provided to citizens would include support for the school to provide physical fitness classes, athletic team practices, games, tournaments, community events, and a safe space for a storm shelter, as well as providing space for additional grades being added to the school (9th grade in 2023-24, 10th grade in 2024-25, etc.).

d. Who is the target population served by this project? How many individuals are expected to be served?

The target population served by site work for the expansion project includes 900+ students from VPK to high school. Additionally, by expanding the campus to include a gym and upper school building, the surrounding community can be served with events, as well as be used as a storm shelter.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

Site work will enable the school to build a gym, allowing our students to be more physically active, which will lead to better grades, academic performance, attendance, classroom behaviors, and school morale. Physical fitness has been shown to improve learning in reading, math, and writing skills. It will also allow the athletic teams the ability to practice and compete in sports without having long travel to rented spaces. The school will conduct physical challenges, such as those found within the President's Physical Fitness Test, at the beginning and end of the school year in order to track improvements. Surveys for the students and parents will also be utilized throughout the year. Using the site work to build an upper school building on campus will allow the school to add additional high school grades and offer a variety of classes. By providing the middle and high school students with their own building, they will have the ability to learn in an age-appropriate environment.
