b. What activities and services will be provided to meet the intended purpose of these funds?

The UF College of Medicine seeks to develop and implement a series of National Excellence Initiatives: programs to train current and future healthcare providers—on campus in Gainesville and statewide—in AI, quality, value, and patient safety, and to advance research in those areas using UF's unique strengths to inform evidence-based practice for practitioners and policymakers.

c. What direct services will be provided to citizens by the appropriation project?

With the state's top-ranked College of Medicine and as the only AI University in the country, UF is uniquely positioned to advance these initiatives, ensuring that Florida is known for an AI-enabled workforce with access to talented students, physicians, and nurses trained in leading-edge methods and able to converse, apply, and contribute to advances in healthcare.

d. Who is the target population served by this project? How many individuals are expected to be served?

In partnership with UF Health, education and training services could benefit residents in all 67 counties.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will

be measured?

The proposed initiatives-Quality and Patient Safety Academy, Center for AI and Implementation Science, Fellowship Training and Student Scholars Programs, BioMedical Artificial Passport Program-will ensure Floridians have access to talented students, physicians, and nurses trained in leading-edge methods and able to converse, apply, and contribute to advances in healthcare. This proposal includes a hybrid fellowship program for healthcare providers, with both experiential work in UF's healthcare system and in-person and web-based education on the fundamentals of quality, patient safety, population health, value, and the patient experience; and a full in-state tuition scholarship for two medical students, directly assisting workforce. Success methodology would include the number of students, physicians, and nurses trained through the various programs; more efficient use of resources, reducing healthcare waste; and the number of advances in quality, patient safety, and value research.
