Additional funds will provide continued support and expansion of a program that, since FY 14-15, has grown from 5,400 students in 780 schools to 101,032 students and 28,924 educators in over 2,800 schools. Additional funding supports professional development for Florida educators.

b. What activities and services will be provided to meet the intended purpose of these funds?

The Professional Learning courses are aligned to Brain-Based Literacy Practices, key literacy goals of the Florida DOE, and personalized to the district/school educator cohorts. Here are some examples of key areas of focus: how to bring the science of reading-based literacy practices into the classroom, designing and implementing explicit word recognition practices.

c. What direct services will be provided to citizens by the appropriation project?

Learning Ally will partner with Florida Department of Education districts, schools, and educators to provide professional learning services grounded in agency, collaboration, and instructional outcomes.

d. Who is the target population served by this project? How many individuals are expected to be served?

The target population is Florida students who benefit from accessible instructional materials and professional development opportunities for educators. Learning Ally anticipates serving 101,032 students and 28,924 educators in over 2,800 schools.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

This program will provide accessible instructional materials to individuals with disabilities and professional development opportunities for educators. Outcome will be measured through educators survey and usage metrics will track overall growth of program utilization and academic success.
