#### a. What specific purpose or goal will be achieved by the funds requested?

Florida DCF currently uses The Work Number in the eligibility determination process for public assistance benefits (Medicaid, SNAP and TANF) to help reduce fraud, waste and abuse. This automated process brings added efficiency to caseworkers so that they can more quickly and accurately determine applicants' employment and income statuses.

Employment and income verifications to increase accuracy of benefit awards, and help reduce fraud, waste, and abuse.

#### c. What direct services will be provided to citizens by the appropriation project?

Public benefit applicants will have their employment and income automatically processed via The Work Number, reducing the time case workers spend evaluating each prospective beneficiary's application and removing the need for applicants to supply self attested information.

#### d. Who is the target population served by this project? How many individuals are expected to be served?

The target population to be served are all public beneficiary applicants. Equifax and DCF project 3.4 million billable transactions based on record matches.

## e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

# In 2012, the DCF conducted a 3-month pilot study of The Work Number. The results of that pilot showed a significant savings as a result of access to accurate, verifiable data on 67.2% of the over 410,000 cases inputted. The estimated annualized savings to the state from the pilot was \$16 million. Since 2012, The Work Number database has grown to house over 2.5 million employers and 140 million active records, which delivers more value to the Department of Children and Families.
