Additionally, JCSO provides 911 services and dispatches for most municipalities and fire rescue services.

JCSO will be able to serve our citizens and visitors by addressing their law enforcement and other emergency needs. By providing a suitable, state-of-the-art complex, our service team can meet the daily demands that keep our community safe. This complex will provide a safe, community friendly atmosphere to serve everyone.
