#### a. What specific purpose or goal will be achieved by the funds requested?



This project aims to create healthy lives for Gadsden County residents.

Gadsden County critically lacks recreational facilities to encourage the residents to stay active and healthy. Currently, there are limited if any County recreational facilities for all youth or adults. Tragically, the two leading causes of death in Gadsden County are obesity- and diabetes-related ailments. Multiple studies have concluded that 92% of Florida residents have access to exercise opportunities. Comparatively, only 59% of Gadsden County's (primarily African American) citizens have access to exercise opportunities.

#### b. What activities and services will be provided to meet the intended purpose of these funds?

rk and multipurpose complex will include a bike-share system, a walking trail sensitive to the environmental preservation of wetlands, and it will encourage the whole community to engage in healthy recreational activities. Also included will be a field, picnic tables with pavilions, and outdoor basketball and tennis courts.

#### c. What direct services will be provided to citizens by the appropriation project?

This project will provide families with a place for family events while enjoying the outdoors and recreational activities. Most importantly, the project will provide Gadsden County's youth a dedicated, safe place to gather, enjoy outdoor recreational activities, and participate in team sports seven days a week.

#### d. Who is the target population served by this project? How many individuals are expected to be served?

All demographics from every walk of life will be served. At least 45,000 individuals will be served.

Improve physical health and enrich cultural experience. Youth and adults will have access to a computer room, community meeting rooms, game rooms, a fitness center, and an indoor basketball court with seating for 200 people.
