**4. Project/Program Description**

The Tampa Police Department is requesting funding to increase its License Plate Reader (LPR) camera deployment by adding approximately 25 additional LPR cameras throughout the city. Statistics reveal a high percentage of criminal activity involves the use of a motor vehicle. Law enforcement investigators utilize information obtained from license plate data to identify vehicle registered owners, which assists law enforcement in identifying suspects and witnesses associated with criminal investigations. Often this is the first investigative lead produced during latent investigations. This technology has also directly contributed to the recovery of stolen vehicles, firearms, contraband, missing persons, and wanted criminals. Additionally, we would like to integrate all investigative resources such as the LPR cameras, City of Tampa CCTV cameras, and even private public facing CCTV cameras (with the owner's consent) into a map-based Real Time Crime Center Data Integration Software system.

**b. What activities and services will be provided to meet the intended purpose of these funds?**

Law enforcement investigators utilize information obtained from license plate data to identify vehicle registered owners, which assists law enforcement in identifying suspects and witnesses associated with criminal investigations. Often this is the first investigative lead produced during latent investigations. This technology has also directly contributed to the recovery of stolen vehicles, firearms, contraband, missing persons, and wanted criminals. LPR cameras also capture vehicle make, color, type, license plate, state of the license plate, missing plate, covered plate, paper plate, and many other unique vehicle details like roof racks and bumper stickers, which drastically increases investigative success.

Crime investigation and reduction.

**d. Who is the target population served by this project? How many individuals are expected to be served?**

All 400,000 residents of the City of Tampa.
