#### 4. Project/Program Description:

The City of Venice utility infrastructure was constructed in the 1950's. Cast iron pipe, 4" diameter or smaller, was used in the distribution of water and has reached its service life expectancy making replacement an absolute necessity. Many years of conveyance has also resulted in tuberculation in the pipelines where carbonate material has formed deposits inside the pipe, growing over time and has limited the flow to residents and businesses. The proposed project is on the island of Venice and in a heavily populated area. The new PVC pipelines will also be relocated from backyard easements and into the street right-of-way for better accessibility, safety and at a lower cost for repair and maintenance. This PVC pipeline material is resistant to tuberculation and will be a larger diameter to increase fire flow protection as well as improved domestic flow and pressure characteristics. This project is Phase 6 of 7 total phases for the Island Water Main Replacement Program.

The Citys 4" in diameter or small cast iron pipes that are currently used in the distribution of water has reached its service life expectancy making replacement an absolute necessity. Many years of conveyance has also resulted in heavy tuberculation in the pipelines where carbonate material has formed deposits inside the pipe, growing over time and has limited the flow to residents and businesses. The proposed project "Water Main Replacement – Phase 6" is on the island of Venice and in a heavily populated area. The new PVC pipelines will be also relocated from the backyard easements and into the street right-of-way for better accessibility, safety and at a lower cost to the City for repair and maintenance. This PVC pipeline material is resistant to tuberculation and will be a larger diameter to increase fire flow protection as well as improved domestic flow and pressure characteristics. This project is Phase 6 of 7 total phases for the Island Water Main Replacement Program.

The funds would be used for construction of City's Water Main Replacement Phase 6 project. The City will install larger diameter PVC pipes which will allow increase in fire flow protection and improve domestic flow and pressure to citizens and businesses.
