Destination Lake: Building a Stronger Community initiative will provide all high school students in Lake County the opportunity to earn job skills and related industry certifications in the construction trades of carpentry, masonry, electrical and plumbing. These trades are high-demand employment sectors in Central Florida and are vital to economic development. a. What is the specific purpose or goal that will be achieved by the funds requested?

Destination Lake's program goals focus on the development of job skills needed for students to graduate, ready to work in a construction trade. Florida's housing growth and the impact of Hurricane Irma, have contributed to these jobs becoming high-demand, high wage employment sectors in Central FL and are vital in the development of high school graduates who are ready to go to work and rebuild Florida. The goals of Destination Lake include: 1. increased graduation rates; 2. increased scores on AP exams; 3. increased percent of students passing the Algebra 1 EOC; 4) increased number of students graduating having earned an industry certification. While Lake Co. schools have historically had a strong, positive relationship with the bs. community, implementation success would require that we foster new relationships based upon student interest and community needs. The increased involvement of the bs. community and all stakeholders will collectively ensure the sustainability of our goals.

b. What are the activities and services that will be provided to meet the intended purpose of these funds?

Destination Lake: Building a Stronger Community, focuses on the revitalization of the Construction Academy at Leesburg High School in partnership with local builders and contractors. Destination Lake will provide students a small career-themed learning community with an emphasis on individualized learning opportunities specific to their academic needs. This initiative includes measures to ensure that capacity is built for sustaining effective teaching and learning to ensure that all students graduate on time, college and/or job ready. Important features of Destination Lake: 1.Job skills training leading to industry certifications, 2.Time allocated for student internships, job shadowing and projects with local contractors. 3.Job embedded professional development that

Leesburg High School is currently in the process of adding an Advanced International Certificate of Education program that will allow students to earn not only a job skill that will lead to high wage jobs, but provide a college preparatory curricula preparing them for postsecondary education. In addition, the program's success will be measured by the number of students getting a job in a construction trade.
