To construct a 4,000 sq.ft. Agricultural Training/Conference Center building at \$125 per sq. ft. located adjacent to the Hardee County Agri-Civic Center & the County Extension/University of Florida Institute of Food & Agricultural Sciences Center that will accommodate up to 200 people & will have the capability to be sectioned into 2 separate rooms that would accommodate 80-100 on each side. This facility would offer a size variety depending on the needs of the conference or training being offered, whether the needs require 200 people or 100 or less. The location is close enough to the restroom facilities of the Agri-Civic Center that serves a local hub for host of agricultural, educational, Fair Association, schools, civic & community events & could utilize them, making this project more cost effective.
