1. Title of Project: Nurse-Family Partnership Statewide Implementation

4. Project/Program Description:

Nurse-Family Partnership is an evidence-based community health program. NFP pairs first-time, high risk pregnant women in poverty with RNs who visit them through pregnancy and until their child turns two. In FL, 44% of participants are teenagers and 73.5% are under age 25. The median income of participants is \$7,500. First-time, low-income, high risk pregnant women and their babies benefit directly and receive personal visits from highly trained RNs. During weekly and biweekly visits, the nurses conduct a range of health assessments, medical check ups, parenting skills development, life skills training, and long-term goal setting/monitoring with participants. The state of Florida also generates cost savings across a range of expenditure areas.

Yes, two more years maximizes the national funding opportunity. Approximately \$1.1 million annually

11. Program Performance:

a. What is the specific purpose or goal that will be achieved by the funds requested?

Nurse-Family Partnership goals: Improve pregnancy outcomes, improve child health & development, improve a family's economic self-sufficiency. 40 years of research demonstrates that NFP generates: 24% decrease in smoking during pregnancy• 27% decrease in pregnancy-induced hypertension• 18% decrease in preterm births
• 60% decrease in infant mortality • 31% decrease in closely-spaced second births •12% increase in moms who attempt to breastfeed•38% less ER use related to child injuries age 0-2•31% decrease in child maltreatment to age 15• 39% decrease in language delay• 46% fewer youth crimes/arrests ages 11-17•53% decrease in alcohol, tobacco & marijuana use (age 12-15)•23% increase in full immunization status • 7% decrease in TANF payments (9 yrs postpartum)• 9% decrease in Food Stamp payments (to 10 yrs postpartum)• 7% decrease in months of Medicaid coverage (15 yrs postpartum)• 15% decrease in costs if on Medicaid (to age 18)• Decrease in subsidized child care caseload (3.6 per 1000)

b. What are the activities and services that will be provided to meet the intended purpose of these funds?

NFP's RNs visit first time high risk women throughout their pregnancy & their child turns 2. During/after disasters, pregnant women are likely to have their prenatal care disrupted placing them at higher risk for preterm birth, low-birth-weight babies & long-term mental health issues. Nurses with maternal & child health backgrounds can facilitate rapid response to minimize the impact of disasters on women and infants. In addition, assessments & parental skills development provided within the program; NFP nurses are able to fill a variety of disaster needs and health concerns for Florida's perinatal/neonatal populations: *Triage/delivery of

care in low resource settings •Respond to altered basic life sustaining requirements for pregnant women & babies •Alleviate psychological burdens for women/children •Nutrition support •Support mental health needs •Promote the importance of contraception access • Appraise environment risks/resources •Evaluate the mitigation/removal of any health hazard

d. What are the direct services to be provided to citizens by the appropriations project?

First-time, low-income, high risk pregnant women and their babies benefit directly and receive personal visits from highly trained RNs. During weekly and biweekly visits, the nurses conduct a range of health assessments, medical check ups, parenting skills development and life skills training, and long-term goal setting/monitoring with participants. The state of Florida also generates cost savings across a range of expenditure areas.

e. Who is the target population served by this project? How many individuals are expected to be served?

<u>First-time</u>, low-income, high risk pregnant women and their babies benefit directly from the program. <u>Immediate family members also receive support</u>. <u>Estimated number of individuals (mothers and babies) to benefit in year 1 - 500</u>.

- f. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?
 - Reduced pregnancy-induced hypertension, decreased smoking during pregnancy, more babies born full term, fewer infant mortalities, Moms setting goals and waiting longer to have a 2nd child, more mothers who initiate and keep breastfeeding, less ER usage for mothers and babies, fewer instances of child maltreatment, improvements in language and motor skills development for babies/toddlers, and reduced costs related to Medicaid, TANF, subsidized childcare, etc. NFP maintains an online, national database that continuously tracks data and outcomes for all implementing sites on more than 30 performance indicators. Many reports are generated that track the progress of sites on these indicators, plus real-time reports on the individual performance and compare to the state and nation. Some of these indicators tracked and reported on include but are not limited to: pre-term births, breastfeeding patterns, hospitalizations, developmental screenings, reports to DCF/other agencies, etc.
