#### 4. Project/Program Description:

Palm Beach State College will create an overdose prevention program to include seminars on substance abuse education and addiction awareness to all incoming students through the Introduction to College Experience classes. The program will offer increased course materials and support for the Addiction Studies program and training for faculty and staff. PBSC will offer the community free educational workshops on addiction and overdose prevention. Continuing Education workshops will also be offered to professionals in areas such as mental health, social work, nursing, and public safety. PBSC will also provide training and doses of Narcan (naloxone) – a life-saving opiate antidote – to campus security.

The purpose is to provide awareness, Narcan training, prevention, resources, recovery support, etc., through addiction awareness workshops, Professional Continuing Education workshops, curriculum in PBSC Addiction Studies program, and free open educational communicty workshops and events.

Educational seminars, training, and workshops for PBSC security, students, faculty, staff, and the community as a whole. Also provided will be doses of Narcan for security personnel and designated staff. Other services include opioid educational CCE credits for all first responder, Florida 491 Board (mental health, social work, marriage, and family therapy), and Florida Certification Board (addiction-specific), and guest speakers for addiction and mental health awareness workshops for the students and community.

Educational seminars, training, and workshops for PBSC security, students, faculty, staff, and the community as a whole. Also provided will be doses of Narcan for security personnel and designated staff. Opioid Educational CCE credits for all first responders, Florida 491 Board (mental health, marriage and family therapy), and Florida Certification Board (addiction-specific); Addication and mental health awareness workshops for the students & community that includes speakers.

e. Who is the target population served by this project? How many individuals are expected to be served?

Persons with poor mental health; Economically disadvantaged persons; Homeless; Drug users (in health services); University/college students; currently or formerly incarcerated persons; and drug offenders (in criminal justice). Greater than 800.

f. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

Decrease potential number of overdoses and deaths from overdoses through distribution of Narcan doses and educational information; Increase number of student and community members who follow up with on-site services after receiving educational information by counting the number of students participating in on-site addiction and mental health counseling and number of those who utilize Baycare Behavioral Health services through PBSC; and providing addiction awareness and treatment resources through seminars, training, workshops, CCE classes, and health services and counting the number of individuals who have received various health and educational services through this initiative.
