Specifically, LSSC and LTC have formed a partnership to promote a variety of workforce programs targeting high school students and adults with the goal of providing them a pathway to training, industry certifications, and associate degrees. The thrust of the program is job readiness along with specific skills that will provide a ready pool of qualified people ready to step directly into the workforce in the fields of programming, digital forensics, web design, web analytics, business, accounting, and emerging media. LSSC will also incorporate a library into this new facility due to its importance in support of the high-skill high-wage education programs offered in the Joint-Use Building.

e. Who is the target population served by this project? How many individuals are expected to be served?

We plan to serve over 2,000 Lake and Sumter County residents such as high school and college students who need educational or career training credentials to advance in their careers.

The State and Lake County are promoting a job-ready workforce in order to attract new industry to the State and region. Lake County is already a partner with LSSC and LTC in promoting economic development in the County. Both LSSC and LTC have outlined the career paths for students and adults to enter workforce training with LTC and then progress onward to LSSC for specific industry certifications and associate degrees. This Joint-Use building will greatly enhance and expand both institutions ability to meet the growing and evolving workforce needs in the area. We will use labor market data from CSCF and internal/external job placement data from LTC and LSSC graduates.
