The Nassau County Council on Aging proposes to provide a Nutrition Support Program (NSP) and requests the amount of \$400,000 in order to offer and prepare hot, nutritious meals for seniors, including the frail and homebound; offer a special meal program for low income veterans; offer training classes to citizens on how to prepare healthy meals, especially for those on medically restricted diets, (learning & training opportunity); and to serve as a disaster response center to feed the entire community when electricity is lost in the wake of a natural disaster, while providing meals & nutrition support to those without electricity.

d. What are the direct services to be provided to citizens by the appropriations project?

Hot meals for those on the waiting list, as well as meals to low income Veterans. Additionally, meals will also be provided for residents affected by natural disasters such as a hurricane, regardless of age. Cooking class demonstrations will be offered for people (of all ages) needing guidance on how to prepare food for restricted diets in order to prolong their life.

e. Who is the target population served by this project? How many individuals are expected to be served?

<u>Target population will be seniors and the disabled as well as veterans</u>. One thousand (1,000) are expected to be served in the first year.

f. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

The expected benefit will be the feeding of 1,000 hungry seniors and veterans each year with hot, nutritious meals as well as serve as a disaster response center in the wake of a hurricane or other natural disaster. There



are many seniors in our community who are hungry and not able to receive meals due to lack of funding, and their respective place on the waiting list. The State will see a reduction in the number of seniors on the SNAP food program as a result of this project as well as doubling the number of meals served from 36,000 to more than 70,000. NO MORE HUNGRY SENIORS WILL BE THE OUTCOME! The methodology for measuring the outcome will be the number of meals served.
