scholarships to local schoolchildren to allow access and transportation to the Class Acts arts-in-education program at The Mahaffey Theater.

e. Who is the target population served by this project? How many individuals are expected to be served?

The diverse citizens of the Tampa Bay community, representing all populations, including youth and economically disadvantaged. Over 220,000 individuals are expected to be served.

f. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

The expected benefits from this project include access for the citizens of the community to experience diverse cultural programming and many receiving donated tickets from aligned non-profit organizations. The Arts Education programming will provide specific curriculum content for local schoolchildren to have an effective learning tool through the arts and economically disadvantaged students will receive scholarships to attend and experience the performing arts. The program will also continue to spur community development, with significant contributions to the overall economic impact on the City.
