4. Project/Program Description:

Emergency Fuel Storage Vaults – City of Largo – This project proposes to strengthen the City of Largo's capacity to respond during emergencies such as hurricanes by providing alternative fuel storage locations to supplement current limited capacity tanks. The City currently stores all of its available fuel in one location in the western half of the City at the Public Works Complex. During the 2017 hurricane season, several issues were identified with this arrangement: 1) no alternative locations for fuel storage in the event the Public Works Facility is inaccessible; and 2) no ability to store an emergency reserve of fuel in the event fuel is unavailable. This project would install two concrete, above ground storage tanks; one in the eastern half of the City at the Wastewater Treatment Plant to fuel lift station generators, and the second in the central section of the City at the Starkey Road Recycling Facility.

Provide alternative fuel storage locations to supplement current limited capacity tanks; thereby ensuring that the City of Largo's first responders (police, fire, paramedics, etc.), emergency operations staff and environmental services/utilities (sanitary sewer) are prepared to respond in emergencies, recover from them, and mitigate against their impacts. The project aligns with the city's strategic plan focus on public health and safety, and helps ensure the City's Initiative #3 (Strategic Plan) under the Public Health and Safety Focus Area: Ensure the health, safety, and economic viability of the community through effective emergency management. The goals aligned with this initiative are: 1) Implement emergency mitigation strategies that reduce the impact of hazards and disasters on the community; and 2) Ensure City services are provided during and after an emergency event.

b. What are the activities and services that will be provided to meet the intended purpose of these funds?

City of Largo will have alternative fuel storage locations; thereby reducing/eliminating reliance on commercial fueling facilities for first responder vehicles and providing fuel to run generators at City facilities, and at sanitary sewer lift stations after a storm/hurricane/disaster.
