Project/Program Description:

Take Stock in Children (TSIC) has offered students a way out of poverty and into higher education through scholarships, mentors, and hope for over 20 years. The founders, a group of education, community, and business leaders frustrated by the large number of at-risk children in Florida not accessing higher education and being shut out of life-changing jobs and opportunities, created a simple, yet transformative solution. Students recruited in middle and high school receive comprehensive support through postsecondary graduation including: a) weekly meetings with a volunteer adult mentor, b) professional post-secondary success and career coaching, c) signing and adhering to a contract to remain drug and crime free and maintain high attendance and grades, and d) a Florida Prepaid scholarship to mitigate the financial barrier of attending college. The results for students in poverty have been extraordinary.

To increase the college and university completion rates of Take Stock in Children students statewide to 97% or better.

b. What are the activities and services that will be provided to meet the intended purpose of these funds?

All of the 6,791 Take Stock in Children students attending Florida's 40 colleges and universities will receive two types of services. First, Student Ambassadors at every one of Florida's 40 colleges and universities will address critical barriers to college completion through on-site peer mentoring and other supports for Take Stock in Children students enrolled at that school. Second, a network of College Completion Coaches will provide robust, professional college completion services to Take Stock and Children students at every Florida college and university. Specifically, they will: a) monitor academic progress to ensure students stay on track for completion, b) cultivate partnerships with postsecondary institutions to leverage every existing program, c) train Student Ambassadors and field more difficult student challenges, d) maximize financial aid by helping students navigate the system and tap into Scholly- an online system that finds millions of dollars in scholarships.

d. What are the direct services to be provided to citizens by the appropriations project?

All of the 6,791 Take Stock in Children students attending Florida's 40 colleges and universities will receive two types of services. First, Student Ambassadors at every one of Florida's 40 colleges and universities will provide them with on-site peer mentoring and other supports to keep them on-track for completion. Second, Take Stock in Children students at all 40 Florida colleges and universities will receive support from a College Completion Coach. Specifically, they will receive: a) monitoring of their academic progress to ensure they stay on track for completion, b) the benefit of being connected to existing college and university resources, c) help through in-person support and the Scholly app to secure more federal and private financial aid, and d) career readiness skill building through in-person coaching and a library of expert web-based courses.

e. Who is the target population served by this project? How many individuals are expected to be served?

Children in poverty who have completed Take Stock in Children and are attending a Florida college or university – 6,791 students in the first year alone.

f. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

The primary benefit of the project is the increased college and university completion rate of Take Stock in Children students which will be measured using college and university data. Additionally, the independent evaluator will select other, research-based indicators that assess If students are on the path to completion.
