d. What are the direct services to be provided to citizens by the appropriations project?

The project will provide cabaret theatre shows, protection from elements, better car access, and more amenities. Students will get "big break" in the industry performing prior to 150 scheduled shows annually. The public may rent the cabaret theatre for meetings and special events. The orchestra shell will enable a full season of shows by The Florida Orchestra.

- e. Who is the target population served by this project? How many individuals are expected to be served?
 - Main stage patrons (261,600), members/guests (4,650), students (1,100,) and the public (11,250 renting cabaret theatre) will be served.
- f. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?
 - The cabaret theatre shows will yield \$2.4 M in spending and \$168,000 in sales tax revenue. This and related projects will create \$1.9 M in lodging, \$138,000 in sales tax revenue, and \$118,000 in hotel tax.
