d. What are the direct services to be provided to citizens by the appropriations project?

TUTORING: We tutor 150 children with one State Certified K-8 Grade Teacher plus volunteer tutors. Since tutors are volunteers, we cannot demand their attendance. We have an urgent need to be able to hire one additional teacher. We currently have four old desktop computer that the tutors use to help these students navigate subjects they are studying in school. We need to purchase four newer laptop computers with updated educational programs and more memory, thus enabling our low income families (most of which do not own a computer or have access to the internet at home) to develop computer knowledge and not fall behind their peers. e. Who is the target population served by this project? How many individuals are expected to be served?

<u>Children from 3-18 years old. Underserved and/or At Risk youth, Economically Disadvantaged Children from the Sweetwater Community. We expect to serve around 310 children.</u>

f. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

Overall, the main benefit that we aim for from all our programs are to give economically disadvantaged children the same educational and physical fitness opportunities granted to any child. Our free tutoring

program helps children unable to afford a private tutor with additional instruction or educational guidance. Our three current Education through Physical Benefits programs (Taekwondo, dance and archery) are aimed at improving Physical and mental health, self-discipline, improving motor skills, self- esteem and confidence. Our upcoming music program (piano and guitar) aims to extend these same benefits to musically-inclined children in our community.
