d. What are the direct services to be provided to citizens by the appropriations project?

New World School of the Arts offers a program of academic and artistic studies in the visual and performing arts which shall be available to talented high school and college students. The general public is exposed to the arts via low cost and free performances and exhibitions

- e. Who is the target population served by this project? How many individuals are expected to be served?
  - High School students' grades, 9-12, College Students freshman -senior year. New World School of the Arts currently enrolls 933 students in its high school and college programs.
- f. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

These expected outcomes for 2017-18 have been reported to the DOE and the Governor's office: A minimum of 98% of high school student will graduate. 80% or higher of high school students will graduate with honors. 50% or higher of college students to graduate with honors. 90% of high school graduating students expected to enroll in post-secondary education. Minimum of 2 guest artists per division to support student learning. Minimum of 5 external awards and honors by students. Minimum of 5 invitations to national or international competitions and/or conferences. 80% of all 9th and 10th grade students will score a satisfactory level (3) or higher on the Florida Standard Assessment, English Language Arts test. An average of 35% of students will score a satisfactory level (3) or higher on the Florida Standard Assessment, algebra 1, algebra 2, and geometry. 60% of high school students will enroll in at least one accelerated mechanism during their high school career.
