1. Title of Project: Town of Lake Park -- Road Striping Improvements

4. Project/Program Description:

This project will add thermoplastic striping and stop bars throughout the Town in order to increase public safety. Thermoplastic can last 10 years, whereas paint generally lasts no more than three. Many roads in the Town do not have centerline or other appropriate striping, which increases the likelihood of accidents. The thermoplastic lines will provide long-term safety enhancements throughout the Town. Thermoplastic stop bars, which are not currently in place, are a safety feature that will add additional visibility to stop signs. The addition of these lines means law enforcement personnel will have an easier time enforcing stop sign violations. Higher quality striping and stop bars will significantly reduce safety concerns and create an improved aesthetic for the Town, resulting in greater interest from developers.

The project will result in each roadway in the Town of Lake Park having appropriate centerline, side, and stop sign striping. As a result, public safety will be increased, transportation conditions will be improved, economic activity and tourism will be increased, and immediate job opportunities will be created.

Well-marked roadways are expected in areas of economic development. Roadway striping activities will help protect the general public from vehicular accidents and improve traffic flow, as motorists will be able to more easily navigate the Town's unique roadway system. In addition, marked roads increase safety for pedestrians (as well as motorists) by clearly defining roadway usage.
