To maintain the City's waterway systems through design and construction of stormwater improvements and pollutant control systems to reduce pollutants discharging from street runoff into waterways as well as reduce tidal flooding in critical infrastructure, walkways, and city streets.

The City will replace and improve aging stormwater infrastructure in numerous locations identified as vulnerable flood areas and those impacted by King Tide events. Funds will be used to address tidal and storm-related flooding of roadways and critical infrastructure by installing new drainage control structures, low-impact green stormwater infrastructure and new tidal valves on drainage outfalls.
