All Faiths is the only food bank serving DeSoto and has provided services in the area for more than 15 years. In 2018, we distributed 1,800,000 pounds of food through 22 local programs and agencies.

The purpose of the project is to establish a new DeSoto County Food and Resource Center, a one-stop shop that will provide food, services and referrals. The project represents a new model for services in rural communities. In addition to establishing a Food and Resource Center, the program also includes food drops in remote areas and migrant housing locations.

### 11. Program Performance:

### a. What is the specific purpose or goal that will be achieved by the funds requested?

In 2017, All Faiths Food Bank in partnership with Gulf Coast Community Foundation, commissioned a Community Assessment of DeSoto County. Based on review of that report, data and research into best practices, All Faiths Food Bank is establishing a one-stop shop, a rural hub where All Faiths would offer emergency food assistance and partner with other local and regional agencies to provide services at the Center. As service gaps are identified, additional agencies will be secured. The Center staff will coordinate communication and case management among local services. Further, the Center can help strengthen and provide infrastructure for the existing local agencies and community. The project also includes food drops in remote areas and at migrant housing. NOTE: there are no charges for any service provided by All Faiths or no rent charged to partner agencies.

#### b. What are the activities and services that will be provided to meet the intended purpose of these funds?

Activities and services include: Client assessment and referrals Application assistance for government programs Services to improve economic/self-sufficiency Receipt, inventory, storage and distribution of food Food drops in remote areas and migrant housing Client tracking information system

#### c. What are the direct services to be provided to citizens by the appropriations project?

Initial services include: Client assessment and referral Application assistance for government programs Assistance with tax returns and EITC Financial literacy Legal assistance Access to fresh produce, protein, dairy Nutrition education

The target population includes low-income families and individuals, working families whose income is insufficient to cover the cost of living, agricultural workers, seniors, veterans, persons living with disabilities.

Improve physical health. Outcome - Decrease number of households that have at least one member with high blood pressure and/or diabetes. Methodology - Client surveys; data from client tracking software. Improve mental health. Outcome - Decrease amount of stress an individual feels.
