Request funding to construct a memorial in Highlands County to recognize the Medal of Honor recipients from the State of Florida. The land has been dedicated by the Highlands County Board of County Commissioners, local business pro bono totals \$130,000 already in place for the project. Building plans are complete, project is ready to launch. The monies requested are to cover the hard costs of concrete, steel and improvements. The memorial will provide an educational opportunity for Central Florida schools for field trips as well as a venue for veterans events. This memorial will also serve as a tourism stop for the local economy. All Medal of Honor recipients will be recognized and citations will be housed in an open air structure in the center of the grounds. A learning center is proposed for future development on the site as well. The Medal of Honor Memorial, Inc is a 501.c3 volunteer organization in Highlands County.
