4. Project/Program Description:

The Florida Orchestra (TFO) has developed an array of successful music programs aimed at improving community wellness in west central Florida by providing opportunities for residents to engage educationally, socially, and emotionally with the world. Programs include school concerts for 4th and 5th grade students; park concerts; family concerts; a community sing-along called "Sing Out! Tampa Bay;" inside the music programs; concerts in hospitals and aging facilities; and chamber concerts in diverse venues throughout Tampa Bay. All of these programs reach 80,000 residents of all ages annually. Additionally, TFO performs programs in Highlands and Citrus Counties where there is no professional orchestra to serve the community. These programs are offered at free or reduced-prices in a variety of accessible venues, most outside the concert hall. At a time when our communities are more disconnected than ever, TFO is bringing people together through community wellness programs based in music.

11. Program Performance:

a. What is the specific purpose or goal that will be achieved by the funds requested?

Orchestra programs and concerts are positioned to provide a unique community service function to residents. Music is the only art form that can bring together such large and diverse groups of people to actively participate and engage in moments of connection. TFO's community wellness programs will reach over 80,000 west central Florida residents of all ages in educational, community, and healthcare settings and the funds requested would provide even greater reach and depth in programming.

b. What are the activities and services that will be provided to meet the intended purpose of these funds?

Activities include school youth concerts; outdoor park concerts; family concert series; community sing-along, "Sing Out! Tampa Bay;" inside the music programs; concerts in hospitals and aging facilities; and chamber concerts in venues throughout Tampa Bay. A health and wellness manager would be hired to strengthen TFO's offerings in healthcare settings. Additionally, TFO provides annual programs in Highlands and Citrus Counties where there is no professional orchestra to serve the community.

c. What are the direct services to be provided to citizens by the appropriations project?

Direct services will include educational concerts, lecture events, and participatory programs. These are all provided for free or at reduced costs to residents.

d. Who is the target population served by this project? How many individuals are expected to be served?

The target population for this project includes residents of Tampa Bay. Individual events will be targeted to specific age groups or community locations. Some of those target populations include elementary students in grades 4 and 5 at school youth concerts, children ages PreK-6th grade at family concerts, aged 55+ populations at health care facilities, and residents of the South St. Pete neighborhood at chamber music concerts. The total number of individuals expected to be served is 80,000.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

TFO's community engagement programs are expected to bring an overall sense of community and wellbeing to residents. Outcomes include increased quality of life and positive impacts on mental wellness among participants and attendees. Educational outcomes include an understanding of musical concepts and historical and cultural context of the music presented. Methodology for measuring these outcomes will include customer surveys, attendance and retention measures, and anecdotal feedback.
