4. Project/Program Description:

Establishment of "quiet zones" will alleviate the impact caused by the opening of the CSX Intermodal Logistics Terminal in Winter Haven, with the shift in freight rail traffic from the "A" Line to the "S" Line to accommodate the operation of SunRail in the Orlando metro area. These two factors have caused an increase in the number of trains traveling through residential areas of Winter Haven. This has created a noise impact in residential areas in the western and southwestern portions of Winter Haven due the increased frequency and timing of trains sounding their horn at road crossings. Residents living within the area impacted by the train's horn have continuously complained to the city about the disruption in their home-lives and are seeking relief through quiet zones.
