By increasing our ability to serve, the Edna Runner Tutorial Center will provide more community children with learning tools to complete their education and enter young adulthood prepared to thrive and contribute.

b. What are the activities and services that will be provided to meet the intended purpose of these funds?

The focus is on academic improvement including homework support, critical thinking skills, individual and group tutoring, and test preparation. Character-building is a valuable part of our approach as students grow confident and resilient through self-discipline, determination, and teamwork.

c. What are the direct services to be provided to citizens by the appropriations project?

On the other end of the spectrum, the senior citizen programs will also be able to include more of the grandparents who are taking care of these children. In families where both parents work or where one (or both) parent(s) may not be part of the household any longer, support for the grandparents is crucial. A raised bed garden will also be constructed for children & community use.

d. Who is the target population served by this project? How many individuals are expected to be served?

The center provides a safe and nurturing environment for at-risk students attending Jupiter schools, from K-8th grade. The majority of our children come from difficult economic and family situations – living in low-income and/or single parent homes. Many receive little or no academic help at home and are struggling in school.

Increase in the number of children and families helped. Parents, principals and teachers appreciate the extra structure and support the Center provides. Many children have reached greater school success as a result. We collaborate with local educators and receive their strong endorsement because our program makes a difference. Students in our program show improvements in test results and grades, and many make significant strides in behavior, social skills, and personal achievement. The Center employs modern educational techniques and the most up-to-date computer technology. The recent addition of iReady software and Chrome Books allows students to work in a platform consistent with the School District of Palm Beach County and teachers are able to monitor individual student progress.
