4. Project/Program Description:

The Riviera Beach Early Learning to Kindergarten Pilot is a comprehensive plan written in collaboration with community stakeholders to support increased Kindergarten readiness and long-term school success. The goal of this visionary initiative is to create a foundation of high quality early education for all three and four-year-olds in the Riviera Beach community.

Currently in its first year of implementation with eight early learning programs, the pilot is established and working towards its preliminary outcomes. Research tells us that true impacts from the project will come in years two and three when results can be tracked across additional groups of children entering Kindergarten and those that have experienced the pilot for longer periods of time. The goal for year two is to continue the work started in year one and add two additional early learning programs along with expanding the educational pipeline down to infants and toddlers.

a. What is the specific purpose or goal that will be achieved by the funds requested?

Increase school readiness and boost long-term school success for the children and families of Riviera Beach through supports to existing community early learning programs.

b. What are the activities and services that will be provided to meet the intended purpose of these funds?

The Riviera Beach Early Learning to Kindergarten Pilot is focused on creating a community support network that assures every child in Riviera Beach has access to a high-quality preschool education. This is a partnership between community stakeholders, Riviera Beach early learning programs, the School District of Palm Beach County, the Children's Services Council of Palm Beach County (a local special taxing district focused on early childhood outcomes) and the Early Learning Coalition of Palm Beach County. The pilot activities are aimed at building upon the existing strengths of each early learning program and supplementing with the following supports and services: Age appropriate curricula, training and implementation support; mental health consultation with each participating program to support educators, children and families; classroom materials to support teaching and learning; partnerships with the School District and the Children's Services Council to maximize supports.

c. What are the direct services to be provided to citizens by the appropriations project?

Support for early learning programs in Riviera Beach through 1) Family supports via family engagement activities 2) Program supports via therapists, education specialists, plus an additional aide per classroom 3) Ongoing independent child assessment to measure progress and plan for continuous improvement 4) CLASS

d. Who is the target population served by this project? How many individuals are expected to be served?

Three and four year old children in Riviera Beach attending partner early learning programs with an estimate of 300 children to be served.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

The Riviera Beach Early Learning to Kindergarten Pilot is focused on an increase in Kindergarten readiness rates and overall school success however the collaborative understands there are multiple factors to reach this goal. Project deliverables include: 1)Family supports and education to increase parental engagement and advocacy 2) Provision of support services for children and families who demonstrate a need in the form of therapy services, speech services and referrals 3)Increasing support to early learning program administrators and teaching staff in the form of professional development and on-site technical assistance to maximize the efforts while children are in program. 4)Creating opportunities for early learning programs and elementary school teachers to dialogue frequently on the transition process and the Kindergarten/school experience.
