 - Funds will be used to provide maintenance of the Bascule Bridge and to support capital improvements required to maintain the bridge in operational order.
- b. What are the activities and services that will be provided to meet the intended purpose of these funds?

 Operation and maintenance of the bridge.
- c. What are the direct services to be provided to citizens by the appropriations project?
 - Maintaining the bridge serves the general public by providing an evacuation route, passable waterways, and a roadway to the mainland.
- d. Who is the target population served by this project? How many individuals are expected to be served?
 - The general public and residents, businesses and tourists of Treasure Island may use the Treasure Island Causeway, which includes the bascule bridge, an evacuation route, and connector to the beaches for St. Petersburg. >10,000 daily
- e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?
 - Improve transportation conditions by providing an evacuation route, and waterway passage, completion of the capital improvements plan for maintenance items and passing the annual state bridge inspection. Each year, the capital improvement plan is evaluated through the annual budget process and an annual state bridge inspection is conducted. Improve economic activity through an increase in re-development and investment in the community and ensure tourists are capable of accessing and exiting the island.
