a. What is the specific purpose or goal that will be achieved by the funds requested?

Capital project to design and construct a new addition onto the existing Juvenile Detention Center and relocate the Juvenile Assessment Center to new addition. This will allow for better oversight of juvenile offenders, enhanced security, as well as create staff and operational efficiencies. This project will also provide additional space for educational classrooms to improve the juveniles educational opportunities and reduce recidivism.

b. What are the activities and services that will be provided to meet the intended purpose of these funds?

This facility will handle all aspects of the juvenile offenders from intake, to processing, to incarceration. Having these facilities combined will increase staff efficiencies, enhance security and provide a safer environment for juvenile offenders.

c. What are the direct services to be provided to citizens by the appropriations project?

Provide juvenile offenders a safe and secure correctional facility. These juveniles will have access to mental health treatment, education, other services that allow them to be productive adults.

d. Who is the target population served by this project? How many individuals are expected to be served?

Juveniles and families of juvenile offenders, approximately 2,000 juveniles per year go through these facilities.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

Juvenile offenders being housed in a safer more secure environment. They will also attend school and have educational opportunities. These juveniles will be able to focus on career paths or jobs and being placed in the workforce.
