### 4. Project/Program Description:

A new emergency operations center (EOC) for Brevard County of sufficient size with modern technology would enable the county to better provide emergency communication, preparedness, training, response, recovery and mitigation for Brevard county citizens and visitors. A new EOC would house the 911 public safety answering point which dispatches emergency medical response throughout the county and fire response in the unincorporated and some incorporated sections of the county. As the heart of emergency response for the county, having a hurricane-hardened facility capable of command and control is critical for contingency activities. The current facility, built in the 1960s, has neither the space nor resiliency needed to survive and respond to major storm activity. As a coastal county with multiple storm impacts, it is critical to secure this funding and continue progress on the new facility.

All citizens, residents, and visitors of Brevard County and east central Florida will be served, due to hazards affecting Brevard and its neighboring counties.
