4. Project/Program Description:

Town Hall serves as the Emergency Operations Center and is used as a "command center" during hurricane events. This vital facility must be hardened in order to provide efficient and effective disaster preparedness activities, interagency coordination, executive decision making, and managing disaster response and recovery services to/for citizenry, prior to/during/after disaster events. Currently, the non-hardened openings are vulnerable to damage due to their weakness should the building envelope be breached. The effectiveness of the town's operations during an emergency could be severely compromised. The existing generator powers the lights but cannot power the AC system or the two elevators. Hardening compliance improvements include hurricane Cat. 3 or 4 resistant doors and windows; a 750 kW diesel emergency backup generator with switchgear and building circuits; upgrade of existing elevators to meet ADA code requirements; and security system and energy efficient lighting.

The goal is to meet state disaster hardened shelter requirements in order to safely operate and house first responders emergency teams to provide efficient and effective disaster preparedness activities, inter-agency coordination, executive decision making, and managing disaster response and recovery services to/for citizenry, residents, visitors, and the surrounding areas prior to/during/after disaster events. Provides for improved life, health, safety and protection.

b. What are the activities and services that will be provided to meet the intended purpose of these funds?

Contractual engineering/architecture and construction services through the town's procurement policy to meet state hardening compliance regulations. Improvements include installing hurricane Cat. 3 or 4 resistant doors and windows; a 750 kW diesel emergency backup generator with switchgear and building circuits; upgrade of existing elevators to meet ADA code requirements; and security system and energy efficient lighting.
