11. Program Performance:

a. What is the specific purpose or goal that will be achieved by the funds requested?

The goal is to continue our proven model of After School programing at 5 Osceola County schools and assist 4 of our Lake County After School Programs, where our 21st CCLC grant will sunset after the 2019/20 school year.

b. What are the activities and services that will be provided to meet the intended purpose of these funds?

On average, the YMCA of Central Florida After School Programs (24 sites across Orange, Lake, and Osceola) serve more than 3,100 students daily. The program will provide academic support along with choice-based club offerings in an effort to improve school-day attendance and GPA's while decreasing juvenile crime. Academic support areas are offered in different formats including: Web-based curriculum, student-led support groups, and group tutoring. Each After School Program block embeds within its activities five content areas: (1) Health and Wellness, (2) STEM, (3) Arts and Humanities, (4) Language Arts, and (5) Social Responsibility (Service Learning). The YMCA of Central Florida After School Programs operate each school day once the final bell rings Summer Camps run Monday through Thursday for 4 weeks in June.

c. What are the direct services to be provided to citizens by the appropriations project?

The YMCA of Central Florida will provide 5 Osceola County Middle Schools and 4 Lake County Middle Schools with programming during the 2019/20 school year.

d. Who is the target population served by this project? How many individuals are expected to be served?

- e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?
 - 80% of the students who regularly participate in the program shall achieve or maintain a GPA of 2.0 or more; or show at least 1/10 of a point increase. (NOTE: In 2017/18, 89% of all YMCA program participants in Osceola County locations accomplished this outcome). The overall average school attendance of regularly attending participants shall be greater than the overall average school attendance of non-participants. (NOTE: In 2017/18, YMCA participants at Osceola County locations missed an average of 7 days, whereas non-participants missed an average of 9). 80% of the students regularly participating in the program shall have no initial or repeat involvement with the juvenile justice system. (NOTE: In 2017/18, 0 YMCA participants at the Osceola County locations had delinquency offenses after their YMCA start date).
- f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for in the contract?

The current standard penalties are all financial in nature if Average Daily Attendance requirements are not met. Should measures not be met in regards to our 3 Performance Outcomes, we would consider drafting Action Plans in partnership with school administration that would ensure that our students are hitting the mark surrounding GPA, school day attendance, and juvenile justice involvement.
