4. Project/Program Description:

(Gadsden Correctional Facility) Shaping Success: A Gender-Focused Behavior Management System (BMS) works by managing behaviors in a structured way that integrates gender-responsive, trauma-informed best practices. Correctional literature suggests that women have different pathways into crime, and a higher prevalence of substance abuse, mental health, and victimization issues, leading to increased suffering and trauma. Emerging research indicates that these factors effect reentry and ultimately recidivism. Informed by gender-responsive, trauma-informed research, this project uses incentives to motivate behavior change towards pro-social targets. Additionally, sanctions are used to reduce undesirable behaviors. The application of these methods is known as behavior shaping. Within a well-designed, gender-responsive BMS, staff recognize behavioral targets and understand how to deliver "reinforcers" and "punishers" in a trauma-informed manner.

Improved gender-responsive and trauma-informed approaches to behavior change, including -Increased engagement in rehabilitative offerings (e.g.- substance abuse, mental health services) -Reduced misconducts - Gains in educational and vocational reentry readiness -Greater best practices staff adherence

b. What are the activities and services that will be provided to meet the intended purpose of these funds?

The level of funding is to provide a systematic approach to behavior management that integrates the research on gender-responsive, trauma-informed care. This will include the development of an incentive/sanction grid, implementation science planning, staff training and coaching, quality assurance, data collection and review.

c. What are the direct services to be provided to citizens by the appropriations project?

The direct services being provided are the implementation of a systematic approach to behavior change through the administration of incentives and sanctions focused on target behaviors. The delivery approach will include a strong understanding of gender-responsivity and female criminogenic needs. The focus will be two-fold: staff behaviors administering this approach, and inmate behaviors related to facility rules and rehabilitative engagement.

The target population includes both incarcerated females housed at Gadsden Correctional Facility and staff employed there. This will serve over 223 staff and up to 1,600 inmates.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

The outcomes will be measured in several ways, including at minimum: program participation, number of mental health referrals, disciplinary infractions, percent of program completions/certifications, inmates satisfaction/perception, incentive/sanction grid usage and staff feedback.
