11. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?

Stetson's Veterans Advocacy Clinic will provide pro bono legal services to veterans seeking health care, compensation for servicerelated injuries, and discharge upgrades.

b. What activities and services will be provided to meet the intended purpose of these funds?

Students and supervising attorneys will assist veterans with their U.S. Department of Veterans Affairs (VA) benefits claims. Students will also help veterans having less than fully honorable military discharges to upgrade their discharge status. Unfavorable discharge statuses are often due to misconduct resulting from post-traumatic stress disorder, military sexual trauma, or traumatic brain injury that occurred during military service.

c. What direct services will be provided to citizens by the appropriation project?

Outreach to veterans and veteran groups, intake interviews, conducting case analysis, performing fact investigations, preparing claims, and drafting briefs.

d. Who is the target population served by this project? How many individuals are expected to be served?

Veterans of our US Armed Forces. 201-400 veterans with meritorious VA claims.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

Probono legal assistance to veteran clients in the Tampa Bay region and across the state of Florida. Assistance includes representation to secure VA benefits, discharge upgrades, and medical exams needed to file and appeal VA claims.

f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for in the contract?

Outcomes of assistance and representation will be tracked and reported via case management and include veterans seeking VA benefits, discharge upgrades, and medical exams to file and appeal VA benefit claims that have been denied.
