1. **Project Title** North Lauderdale C-14 Pump Station2. **Senate Sponsor** Perry Thurston3. **Date of Request** 10/11/20194. **Project/Program Description**

Intense storm events have historically caused major flooding issues on City of North Lauderdale roadways and in backyards of residential properties adjacent to the City's canals. The flooding mandates road closures for extended periods of time causing traffic congestion and affecting daily commutes for City residents and outside commuters. Damages to residential property and roadways after an intense storm are a frequent occurrence. The best way to protect the residential property roadways is to install the City's own drainage pump structure in the C-14 canal. This structure will enable the lowering of the canal levels in the City's drainage network and will work in tandem with the other municipal pumps discharging into the C-14 canal. The City will be able to monitor the canal levels and manage the flow of the water more effectively. If a drainage pump structure is not installed the City will continue to face challenges of frequent flooding of the roadways and residential property.

#### 11. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?

The specific purpose of the funds is to provide a drainage pump for the City's C-14 canal in order to manage the water levels in the canal drainage network. Currently there is only a gravity system to move the water out into the South Florida Management C-14 canal system. The recent intense storm events have caused major flooding issues on community roadways and the stormwater runoff has caused damage to property as the gravity drainage system cannot adjust the water levels in the C-14 canal quickly enough. The best way to protect the property of the citizens of North Lauderdale and community roadways is to install the City's own drainage pump structure that can lower the canal levels in the City's canal drainage network discharging into the C-14 canal.

b. What activities and services will be provided to meet the intended purpose of these funds?

Installation of the C-14 drainage pump station to control the water levels in the City's canal system.

c. What direct services will be provided to citizens by the appropriation project?

A significant decrease of flooding to the City's roadways and properties that are adjacent to City canals or near storm structures.

d. Who is the target population served by this project? How many individuals are expected to be served?

All citizens and visitors to the City.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

The benefit will be a significant decrease of flooding events in the City of North Lauderdale once the canal system is controlled by a pump station so the canal levels can be lowered to add more volume for the stormwater run off. This will be measured by number of documented road closures for safety concerns and amount of property damage.
