a. What specific purpose or goal will be achieved by the funds requested?

This project will minimize flooding problems in the business community. Enhance the quality of surface water runoff by reducing contaminants in the swale/French Drainage Systems and treat water prior to reaching the Floridan Aquifer and canals (C-8 Biscayne Canal).

b. What activities and services will be provided to meet the intended purpose of these funds?

The installation of drainage systems, road re-surfacing, stripping, sidewalks and ADA ramps installation. This funding is for construction only.

c. What direct services will be provided to citizens by the appropriation project?

There will be no direct services, but benefiting the whole business and visitor community that drive through the area to conduct business in the industrial area on NW 159 Street. In addition, NW 159 Street off east of NW 57 Avenue floods on the road that vehicles, if speeding, may hydroplane and cause a head-on collision with the opposite traffic.

d. Who is the target population served by this project? How many individuals are expected to be served?

The NW 159 Street area - serving approximately 150 -200 individuals that do business in the industrial area.
