Multiple civic activities are held each year at the clubhouse ranging from banquets, meetings, and parties. The RV park has 4th of July celebrations, concerts, craft festivals, and fishing tournaments held on the Apalachicola River.

c. What direct services will be provided to citizens by the appropriation project?

The clubhouse would be available for parties, reunions, banquets, wedding receptions, and the like. The park would be available for festivals, fishing tournaments, concerts, picnics, parties, and celebrations.

d. Who is the target population served by this project? How many individuals are expected to be served?

The target population to be served is all the residents of the City of Chattahoochee and the surrounding rural Gadsden County residents as well as out of town tourists.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

The expected outcome of this project is to make the park usable again to the citizens and visitors of Chattahoochee, which in turn would promote tourism and generate local revenue. The increased usage of the park can be measured through the booking log for the clubhouse and RV sites.
