11. Program Performance

a. What specific purpose or goal will be achieved by the funds requested?

The purpose is to continue to provide, enrich, enhance and implement the Holocaust Documentation & Education Center, Inc., Educational Outreach programs and resources to meet the requirements of s. 1003.42, F.S., mandating Holocaust Education.

b. What activities and services will be provided to meet the intended purpose of these funds?

The activities and services that will be provided include: • Student Awareness Days, prejudice reduction and anti-bullying programs • Authenticated Holocaust Railcar and U.S. M-4A3E8 Sherman Tank Tours • Speakers Bureau • Olga & Eugene Guttman Visual Arts and Writing Contest • "A Simple Act of Kindness Contest" • Meet the Author Series • Traveling Exhibition • Teacher Institute

In addition, a production of USB Student/Teacher resource on Holocaust Education will be developed.

c. What direct services will be provided to citizens by the appropriation project?

The Holocaust Documentation & Education Center, Inc. offers a variety of programs to compliment the mission to preserve, protect, and perpetuate the authentic legacy of the Holocaust. One of these vehicles is the traveling exhibitions. In 2018, the HDEC presented two exhibitions, State of Deception: The Power of Nazi Propaganda and Operation Finale: The Capture & Trial of Adolf Eichmann. Lectures, panels, and programs were held with these exhibitions. The newest programs include Music & Words with the German Consulate and an upcoming program The Kurt Waldheim Affair: The Postwar World's Most Sensational Nazi Scandal with Eli Rosenbaum and Neal Sher. Through these programs and others, participants gain an understanding of the ramifications of prejudice, racism, and stereotyping, and of what it means to be a responsible and respectful person, for the purposes of encouraging diversity in a pluralistic society and for nurturing and protecting democratic values and institutions.

d. Who is the target population served by this project? How many individuals are expected to be served?

The programs offered by the Holocaust Documentation & Education Center, Inc., reach participants of all ages. The HDEC Annual Contests are open to students K-University, nationally, and Student Awareness Day programs which feature interaction with Holocaust Survivors for a full day bringing history to life and is a highlight of the students, life experiences. These programs impact public, private, and parochial High School students in Miami-Dade and Broward counties. The Speakers Bureau Holocaust Survivors speak to community members of all ages across South Florida and visitors ages 10 and up are encouraged to take tours of an authenticated, identified Holocaust Railcar and U.S. M-4A3E8 Sherman Tank. Through various endeavors, all who come into contact with Survivors and programs learn that no one is immune to bullying and injustice and that it is the job of all to stand up and speak out against hatred!

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

Being a part of a ethnically diversified community in South Florida, the Holocaust Documentation & Education Center, Inc., strives to promote the ideals of justice and acceptance to all no matter race, religion, gender, or creed to learn from the survivor's experience the significance and importance of standing up and speaking out in the face of adversity. To that end, the programs center around prejudice-reduction and education of the Holocaust. All participants are educated on what can happen if prejudice and violence are left unchecked to ensure that what happened to the survivors never happens again. These programs resonate with students of all backgrounds. Some of the most frequent comments received is that students now appreciate what they have more, and wish to make a difference in their communities to ensure that NEVER AGAIN really does mean NEVER AGAIN.
