The Child Finder Tracker is promoted within the advocate community to recruit, track, and match families waiting for foster care, lessening the burden on the State to house children in group homes and/or general care.

The direct services will be building families and improving tracking, which is currently done manually. This service will allow the provider the prospective parent and approved advocates access to the matching and tracking system.

At risk youth, developmentally disabled, physically disabled, preschool students, grade school students, high school students.
