Enhanced safety measures to enable students to get to and from school safely using means other than motor vehicles due to a lack of school bus services for those students who reside within a two-mile radius of schools.

c. What direct services will be provided to citizens by the appropriation project?

Construction of sidewalks, lighting, marked crosswalks, warning devices, and other pedestrian and bicycling safety enhancements near schools.

d. Who is the target population served by this project? How many individuals are expected to be served?

Grade school and high school students.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

An increase in students walking and/or cycling to and from school as a result of new sidewalks and safety enhancements. The number of students being transported prior to enhancements versus the number of students walking and/or cycling after enhancements - total new miles being walked and/or cycled by students.
