a. What specific purpose or goal will be achieved by the funds requested?

The project will fund improvements to parking, the stormwater management system, and the HVAC system to support the Possum Palace. The facility is a public space for events, seminars, training, courses, voting, school events, and any other events approved by the town council.

b. What activities and services will be provided to meet the intended purpose of these funds?

Paved parking, stormwater management system, and HVAC equipment for the Possum Palace

c. What direct services will be provided to citizens by the appropriation project?

Air-conditioned community space and parking for local residents and visitors attending events and activities at the facility.

d. Who is the target population served by this project? How many individuals are expected to be served?

The target population is the entire population of the Town of Wausau, residents of Washington County, and tourists. Population is estimated to be greater than 2,500 people.

e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

An increase in tourism, which can be measured by comparing the attendance to the events and activities provided at the facility vs. those provided at the upgraded facility after 1 year. An increase in town revenue, which can be measured by the amount of income from the rental of the space. An increase in education and reduction in crime due to the ability for the town to hold events, activities, and courses for residents, which can be measured by the attendance.

f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for in the contract?

The funding may be eliminated due to lack of performance.
