### 11. Program Performance

### a. What specific purpose or goal will be achieved by the funds requested?

The funds will be used for the Youth Smoothie Bar Social Enterprise program to teach children and teens the business of this youth entrepreneur venture. They will become healthy by learning to grow their own fruits and veggies and to grow a business on healthy ingredients and supplies. Youth will learn about business development, they will address health concerns and provide healthy food in one of the area's food desert. The social venture will prepare youth for jobs and for creating their own businesses.

#### b. What activities and services will be provided to meet the intended purpose of these funds?

Direct services will include offering a place to purchase healthy foods and introduction to our local agriculture business. Residents with health problems will receive information to address healthy decisions. They will be offered opportunities to work in the community garden and participate in complementary physical fitness activities in the community center. The impact of this will be reduced medical problems, especially those that can be prevented through better decisions, more physical activities and available health-based food in the food desert community in which the smoothie bar will be located.

#### c. What direct services will be provided to citizens by the appropriation project?

Improve agricultural production/promote/educate: At-risk youth and children will learn about agricultural products, growing and harvesting produce and will learn how to promote and attract customers based on the smoothie bar business. They will have handson management and this social venture will directly improve their economic knowledge and activities. Young participants who are trained in business and management will be prepared to either build their own business or be ready for employment.

### d. Who is the target population served by this project? How many individuals are expected to be served?

The population are middle and older teens who are considered to be at-risk, mostly from lower-income families and those who are economically disadvantaged. Up to 200 participants will be served in the program.

## e. What is the expected benefit or outcome of this project? What is the methodology by which this outcome will be measured?

Expected benefits will be training in business development and business management for middle and older teens. They will participate in hands-on activities and will be given tolls for running a successful enterprise. This knowledge will provide teens with the ability to choose productive pathways as they grow into young adults. Participation in agriculture will introduce them to this field and healthy eating and healthy activities will be benefitial as well. University of South Florida professiolas will develop the monitoring and evaluation plan to measure pre and post results. USF business students will provide oversight and support for administration.

## f. What are the suggested penalties that the contracting agency may consider in addition to its standard penalties for failing to meet deliverables or performance measures provided for in the contract?

Agency will be required to reimburse funds unless extreme situations and activities such as natural disasters that are entirely out of the agency's control, prevent the comletion of the project.
