Each state executive committee shall include, as at-large committeemen and committeewomen, all members of the United States Congress representing the State of Florida who are members of the political party, all statewide elected officials who are members of the party, and all members of the Legislature who are members of the political party.the

President of the Senate or the Minority Leader in the Senate,
