following information: the amount of the gift or nature of the gift; the recipient of the gift; the direct relationship of the gift to the educational mission of the university; and the direct benefit of the gift to the university. The university board of trustees shall forward such information to the State Board of Education by December 31 of each year.

Section 5. Paragraph (c) of subsection (4) of section 240.3315, Florida Statutes, is amended to read:

240.3315 Statewide community college direct-support organizations.--

- (4) RESTRICTIONS.--
- (c) A statewide community college direct-support organization is prohibited from giving, either directly or indirectly, any gift to a political committee or committee of continuous existence as defined in s. 106.011 for any purpose other than those certified by a majority roll call vote of the governing board of the direct-support organization at a regularly scheduled meeting as being directly related to the educational mission of the State Board of Community Colleges. Any gift by a direct-support organization, either direct or indirect, with a value in excess of \$1000 must be immediately reported to the community college board of trustees. report must include the following information: the amount of the gift or nature of the gift; the recipient of the gift; the direct relationship of the gift to the educational mission of the community college; and the direct benefit of the gift to the community college. The community college board of trustees shall forward such information to the State Board of Education by December 31 of each year.
