Section 101.657, Florida Statutes, is 18 19 amended to read: 20 101.657 Early voting absentee ballots in person. --21 (1) Any qualified and registered elector may pick up 22 and vote an absentee ballot in person at the office of, and 23 under the supervision of, the supervisor of elections. Before receiving the ballot, the elector must present a Florida 24 25 driver's license, a Florida identification card issued under s. 322.051, or another form of picture identification approved 26 27 by the Department of State. If the elector fails to furnish 28 the required identification, or if the supervisor is in doubt as to the identity of the elector, the supervisor must follow 29 30 the procedure prescribed in s. 101.49. 31

1 (1)(a) (2) As an alternative to the provisions of ss. 2 101.64, and 101.65, and 101.659, the supervisor of elections 3 shall may allow an elector to vote early cast an absentee 4 ballot in the main or branch office of the supervisor by depositing a the voted ballot in a voting device used by the 5 б supervisor to collect or tabulate ballots. The results or 7 tabulation may not be made before the close of the polls on 8 election day. 9 (b) The supervisor shall designate at least one early 10 voting location for every 85,000 voters registered to vote in 11 the election. Except as otherwise provided in this section, each early voting location must meet the requirements for a 12 polling place under the election code. The selection of early 13 14 voting locations must be designed to provide all voters in the county with an equal opportunity to cast a ballot, insofar as 15 16 is practicable. 17 (c) Early voting shall commence at 9 a.m. on the 10th 18 day before an election and conclude at 5 p.m. on the day 19 before the election. I understand that if I commit or attempt to 2 3 commit fraud in connection with voting, vote a fraudulent ballot, or vote more than once in an election I could be 4 5 convicted of a felony of the third degree and both fined up to б \$5,000 and imprisoned for up to 5 years. I understand that my 7 failure to sign this certificate and have my signature 8 witnessed invalidates my ballot. 9 10 11 ... Section 101.659, Florida Statutes, is 15 created to read: 16 17 101.659 Voting absentee ballots in person.--Any qualified and registered elector may pick up and vote an 18 19 absentee ballot in person at the office of, and under the supervision of, the supervisor of elections. Before receiving 20 the ballot, the elector must present a Florida driver's 21 license, a Florida identification card issued under s. 22 322.051, or another form of picture identification approved by 23 24 the Department of State. If the elector fails to furnish the required identification, or if the supervisor is in doubt as 25 to the identity of the elector, the supervisor must follow the 26 27 procedure prescribed in s. 101.49. 28 Section 3. This act shall take effect January 1, 2004. 29 30 31

SENATE SUMMARY
SENATE SUMMARY Requires that supervisors of elections allow early voting during a 10-day period before each election. Requires a polling place to be open from 9 a.m. to 5 p.m. on weekdays and to be open for a total of 10 hours on weekends during the period for early voting. Provides that it is a first-degree misdemeanor for a supervisor of elections to fail to provide for early voting.
